

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.RockTheNeedle.com, and Rock The Needle Quilt Company, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Rock The Needle Quilt Company, LLC include www.RockTheNeedle.com and Rock The Needle. The Rock The Needle website is a Long Arm Quilting Services and Quilting Related Products site. By using the Rock The Needle website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Rock The Needle may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Quilt Images

If you purchase Rock The Needle's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Rock The Needle collects and uses your personal information to operate and deliver the services you have requested.

Rock The Needle may also use your personally identifiable information to inform you of other products or services available from Rock The Needle and its affiliates.

Sharing Information with Third Parties

Rock The Needle does not sell, rent or lease its customer lists to third parties.

Rock The Needle may, from time to time, contact you on behalf of external business partners

about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Rock The Needle may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Rock The Needle, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Rock The Needle may keep track of the websites and pages our users visit within Rock The Needle, in order to determine what Rock The Needle services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Rock The Needle. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Rock The Needle website.

Use of Cookies

The Rock The Needle website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Right to Deletion

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the

- public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
 - Comply with an existing legal obligation; or
 - Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
